Project Light (Company), headquartered in Sydney with an office in Melbourne, is a network and communication services provider in the Building Internet of Things (BloT) industry.

The Company is establishing the smart building network utilising emergency lights as network access points (EMIoT) to allow devices within a building to communicate.

An international patent on data network for buildings and IoT applications has been filed with Patent Cooperation Treaty (PCT) in 2019 to cover Australia, China and the USA amongst 152 countries.








Patented Technology

- The LoRa-mesh network technology enables one gateway to connect all devices in the entire building to the internet with self-healing capability mitigating device failure risk
- Each node has a Bluetooth Low Energy (BLE) radio module allowing any device with BLE capability to join the network and connect to the internet
- The communications within the LoRa-mesh are protected by 128-bit Advanced Security Standard (AES), and the open BloT network is safeguarded by BLE 4.2 security standard
- The BloT network is built on top of existing emergency lights which can be replaced with a low price BloT module via "plug and play" to have networking capability while in compliance with AS2293.2 automatic testing requirements







